SYNOPSIS

On Monday August 31st 2009 at approximately 2150 hrs, Police received a call to attend Bloor Street W, East of Avenue Road regarding a personal injury accident involving a cyclist and an automobile.

The cyclist involved, **SHEPPARD**, Darcy 1975.10.11 in the collision had severe injuries. SHEPPARD was transported to St Michael's Hospital. At 2306 hrs, SHEPPARD was pronounced dead.

Police had received information that the involved vehicle was at the Hyatt Hotel on Bloor Street West. The vehicle involved, bearing a marker _____ was impounded and taken to 9 Hanna Avenue.
